AKTA KASTAM 1967

PERATURAN-PERATURAN KASTAM (PINDAAN) (NO. 2) 2016

PADA menjalankan kuasa yang diberikan oleh seksyen 142 Akta Kastam 1967 [Akta 235], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Pindaan) (No. 2) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Ogos 2016.

Pindaan peraturan 3

2. Peraturan-Peraturan Kastam 1977 [*P.U. (A) 162/1977*], yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam peraturan 3—

(a) dalam subperaturan (1)—

(i) dengan menggantikan noktah di hujung proviso (xxxiii) dengan koma bertitik; dan

(ii) dengan memasukkan selepas proviso (xxxiii) proviso yang berikut:

“(xxxiv) di Pengkalan Bekalan Tok Bali, Mukim Semerak, Jajahan Pasir Puteh, Kelantan, waktu-waktu itu adalah—

pada setiap masa pada mana-mana hari.”;
dan

(b) dalam subperaturan (4)—

- (i) dengan menggantikan noktah di hujung proviso (xxxii) dengan koma bertitik; dan
- (ii) dengan memasukkan selepas proviso (xxxii) proviso yang berikut:

“(xxxiii) di Pengkalan Bekalan Tok Bali, Mukim Semerak, Jajahan Pasir Puteh, Kelantan, waktu-waktu itu adalah—

pada setiap masa pada mana-mana hari.”.

Pindaan Jadual Pertama

CUSTOMS ACT 1967

CUSTOMS (AMENDMENT) (NO. 2) REGULATIONS 2016

IN exercise of the powers conferred by section 142 of the Customs Act 1967 [Act 235], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Amendment) (No. 2) Regulations 2016**.

(2) These Regulations come into operation on 1 August 2016.

Amendment of regulation 3

2. The Customs Regulations 1977 [*P.U. (A) 162/1977*], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 3—

(a) in subregulation (1)—

(i) by substituting for the full stop at the end of proviso (xxxiii) a semi-colon; and

(ii) by inserting after proviso (xxxiii) the following proviso:

“(xxxiv) at Tok Bali Supply Base, Mukim Semerak, Jajahan Pasir Puteh, Kelantan, the hours shall be—

at all times on any day.”; and

(b) in subregulation (4)—

(i) by substituting for the full stop at the end of proviso (xxxii) a semi-colon; and

(ii) by inserting after proviso (xxxii) the following proviso:

“(xxxiii) at Tok Bali Supply Base, Mukim Semerak, Jajahan Pasir Puteh, Kelantan, the hours shall be—

at all times on any day.”.

Amendment of First Schedule

3. The principal Regulations are amended in the First Schedule, in Part I, by inserting after the Customs Port “Kota Bharu” and the particulars relating to it the following particulars:
