AKTA KASTAM 1967

PERATURAN-PERATURAN KASTAM (PINDAAN) (NO. 3) 2016

PADA menjalankan kuasa yang diberikan oleh seksyen 142 Akta Kastam 1967 [Akta 235], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Pindaan) (No. 3) 2016**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Ogos 2016.

Pindaan peraturan 3

2. Peraturan-Peraturan Kastam 1977 [*P.U. (A) 162/1977*], yang disebut "Peraturan-Peraturan ibu" dalam Peraturan-Peraturan ini, dipinda dalam peraturan 3—

(a) dalam subperaturan (1)—

(i) dengan menggantikan noktah di hujung proviso (xxxiv) dengan koma bernoktah; dan

(ii) dengan memasukkan selepas proviso (xxxiv) proviso yang berikut:

“(xxxv) di Tanjung Langsat, Mukim Sungai Tiram, Daerah Johor Bahru, Johor, waktu-waktu itu adalah—

pada setiap masa pada mana-mana hari.”; dan

(b) dalam subperaturan (4)—

(i) dengan menggantikan noktah di hujung proviso (xxxiii) dengan koma bernoktah; dan

(ii) dengan memasukkan selepas proviso (xxxiii) proviso yang berikut:

“(xxxiv) di Tanjung Langsat, Mukim Sungai Tiram, Daerah Johor Bahru, Johor, waktu-waktu itu adalah—

pada setiap masa pada mana-mana hari.”.

Pindaan Jadual Pertama

3. Peraturan-Peraturan ibu dipinda dalam Jadual Pertama, dalam Bahagian I, di bawah subkepala “Negeri-Negeri Tanah Melayu” dengan menggantikan Port Kastam “Tanjung Langsat, Johor” dan butir-butir yang berhubungan dengannya dengan butir-butir yang berikut:

CUSTOMS ACT 1967

CUSTOMS (AMENDMENT) (NO. 3) REGULATIONS 2016

IN exercise of the powers conferred by section 142 of the Customs Act 1967 [Act 235], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Amendment) (No. 3) Regulations 2016**.

(2) These Regulations come into operation on 1 August 2016.

Amendment of regulation 3

2. The Customs Regulations 1977 [*P.U. (A) 162/1977*], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 3—

(a) in subregulation (1)—

(i) by substituting for the full stop at the end of proviso (xxxiv) a semi-colon; and

(ii) by inserting after proviso (xxxiv) the following proviso:

“(xxxv) at Tanjung Langsat, Mukim Sungai Tiram, District of Johor Bahru, Johor, the hours shall be—

at all times on any day.”; and

(b) in subregulation (4)—

(i) by substituting for the full stop at the end of proviso (xxxiii) a semi-colon; and

(ii) by inserting after proviso (xxxiii) the following proviso:

“(xxxiv) at Tanjung Langsat, Mukim Sungai Tiram, District of Johor Bahru, Johor, the hours shall be—

at all times on any day.”.

Amendment of First Schedule

3. The principal Regulations are amended in the First Schedule, in Part I, under the subheading “States of Malaya” by substituting for the Customs Port “Tanjung Langsat, Johor” and the particulars relating to it the following particulars:
