AKTA KASTAM 1967

PERATURAN-PERATURAN KASTAM (FI LESEN IMPORT KENDERAAN BERMOTOR)
(PINDAAN) 2015

PADA menjalankan kuasa yang diberikan oleh subseksyen 142(15) Akta Kastam 1967 [*Akta 235*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Fi Lesen Import Kenderaan Bermotor) (Pindaan) 2015**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 31 Disember 2015.

Pindaan peraturan 1

2. Peraturan-Peraturan Kastam (Fi Lesen Import Kenderaan Bermotor) 2009 [*P.U. (A) 491/2009*] yang disebut “Peraturan-Peraturan ibu” dalam Peraturan-Peraturan ini, dipinda dalam subperaturan 1(2) dengan memotong perkataan “hingga 31 Disember 2015”.

Pindaan peraturan 2

3. Subperaturan 2(1) Peraturan-Peraturan ibu dipinda dengan menggantikan perkataan “Perintah Kastam (Larangan Mengenai Import) 2008 [*P.U. (A) 86/2008*]” dengan perkataan “Perintah Kastam (Larangan Mengenai Import) 2012 [*P.U. (A) 490/2012*]”.

Pindaan Jadual

4. Peraturan-Peraturan ibu dipinda dalam Jadual—

(a) berhubung dengan butiran 1, dalam ruang (3), dengan menggantikan perkataan “6287-V” dengan perkataan “62847-V”; dan

(b) berhubung dengan butiran 44, dalam ruang (3), dengan menggantikan perkataan “91431-U” dengan perkataan “92431-U”.

CUSTOMS ACT 1967

CUSTOMS (IMPORT LICENCE FEE FOR MOTOR VEHICLE) (AMENDMENT)
REGULATIONS 2015

IN exercise of the powers conferred by subsection 142(15) of the Customs Act 1967 [Act 235], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Import Licence Fee for Motor Vehicle) (Amendment) Regulations 2015**.

(2) These Regulations come into operation on 31 December 2015.

Amendment of regulation 1

2. The Customs (Import Licence Fee for Motor Vehicle) Regulations 2009 [P.U. (A) 491/2009] which are referred to as the “principal Regulations” in these Regulations, are amended in subregulation 1(2) by deleting the words “to 31 December 2015”.

Amendment of regulation 2

3. Subregulation 2(1) of the principal Regulations is amended by substituting for the words “Customs (Prohibitions of Imports) Order 2008 [P.U. (A) 86/2008]” the words “Customs (Prohibitions of Imports) Order 2012 [P.U. (A) 490/2012]”.

Amendment of Schedule

4. The principal Regulations are amended in the Schedule—

(a) in relation to item 1, in column (3), by substituting for the words “6287-V” the words “62847-V”; and

(b) in relation to item 44, in column (3), by substituting for the words “91431-U” the words “92431-U”.
