PERINTAH DUTI EKSAIS (PANGKOR) (PINDAAN) 2023

PADA menjalankan kuasa yang diberikan oleh perenggan 91U(1)(a) dibaca bersama dengan perenggan 91v(b) Akta Eksais 1976 [*Akta 176*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Eksais (Pangkor) (Pindaan) 2023**.

(2) Perintah ini mula berkuat kuasa pada 1 April 2023.

**Pindaan perenggan 2**

2. Perintah Duti Eksais (Pangkor) 2022 [*P.U. (A) 174/2022*] dipinda dalam subsubperenggan 2(f) dengan menggantikan perkataan “yang tidak mengandungi nikotin” dengan perkataan “sama ada mengandungi nikotin atau tidak”.

EXCISE ACT 1976

EXCISE DUTIES (PANGKOR) (AMENDMENT) ORDER 2023

IN exercise of the powers conferred by paragraph 91U(1)(a) read together with paragraph 91V(b) of the Excise Act 1976 [Act 176], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Excise Duties (Pangkor) (Amendment) Order 2023**.

(2) This Order comes into operation on 1 April 2023.

**Amendment of paragraph 2**

2. The Excise Duties (Pangkor) Order 2022 [P.U. (A) 174/2022] is amended in subsubparagraph 2(f) by substituting for the words “not containing nicotine” the words “whether or not containing nicotine”.
