Keterangan barangan :

Barangan adalah sejenis minuman yang dihasilkan daripada campuran jus buah (*red grape, pomegranate, peach, acerola, elderberry, blackcurrant, aronia, blackberry*), dan *dried herb infusion (couch grass root, stinging nettle, horsetail, yarrow, verbena, rooibos)*. Barangan dipek dalam botol kaca berukuran isipadu 330ml dan boleh digunakan sebagai minuman yang boleh diminum terus atau dicampur dengan air.

Ketetapan:

Ketua Pengarah Kastam Malaysia memutuskan barangan sesuai diklasifikasikan di bawah kod tarif **2202.99.50 00** sebagai **Non-aerated beverages ready for consumption without dilution based on mixed fruits juice and herbs infusion** berdasarkan alasan-alasan berikut:

- Barangan terdiri daripada jus buah-buahan yang dicampur dengan *watery infusion dried herbs* yang boleh diminum terus atau dicampur dengan air.
- Barangan mendapat liputan di bawah *heading 22.02* dalam EN HS 2017, para (B) ms. IV-2202-1 :

(B) *Other non-alcoholic beverages, not including fruit or vegetable juices of heading 20.09.*

This group includes, inter alia:

(1) *Tamarind nectar rendered ready for consumption as a beverage by the addition of water and sugar and straining*

(2) *Certain other beverages ready for consumption, such as those with a basis of milk and cocoa*
