PERINTAH KASTAM (DUTI ANTI-LAMBAKAN) (KAJIAN SEMULA DIPERCEPAT) 2020

PADA menjalankan kuasa yang diberikan oleh subseksyen 28B(1) Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Dipercepat) 2020**.

(2) Perintah ini hendaklah mula berkuat kuasa pada 11 Disember 2020.

2. Duti anti-lambakan yang dikenakan di bawah Perintah Kastam (Duti Anti-Lambakan) 2020 [*P.U. (A) 22/2020*] tidak boleh dilevi ke atas dan dibayar oleh Kaptan Demir Celik Sanayii VE A.S. pengeksport keluaran batang penulangan konkrit keluli dari Republik Turki semasa kajian semula dipercepat sedang dijalankan dari 11 Disember 2020 hingga 7 Jun 2021.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967
CUSTOMS (ANTI-DUMPING DUTIES) (EXPEDITED REVIEW) ORDER 2020

IN exercise of the powers conferred by subsection 28B(1) of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Expedited Review) Order 2020**.

(2) This Order shall come into operation on 11 December 2020.

Period of expedited review

2. The anti-dumping duties imposed under the Customs (Anti-Dumping Duties) Order 2020 [*P.U. (A) 22/2020*] shall not be levied on and paid by Kaptan Demir Celik Sanayii VE A.S. the exporter of steel concrete reinforcing bar products from the Republic of Turkey while the expedited review is being carried out from 11 December 2020 until 7 June 2021.
