Multi level parking system adalah suatu ruang letak kereta bertingkat-tingkat yang diurus secara sistematik dimana peralatannya antara lain terdiri daripada steel bars,motor,chain control board,stopper switch,sensor,gate top level lifting and lowering pallets,ground motion pallets,intermediate layer pallets.

Ianya merealisasikan penggunaan ruang letak kereta yang lebih efisien kepada masyarakat bandar dengan ruang letak kereta atas dan bawah tanah dengan menyediakan lot yang bertingkat-tingkat.

Cara penggunaan :

- (a) Operator akan memberi input no.parking pallet(kosong) tertentu melalui operation control board.
- (b) Sistem akan membuat penyusunan dimana parking pallet yang telah dikenalpasti oleh LCD panel,akan digerakkan secara selari,dalam gerakan mendatar dan menegak untuk mengambil ruang pada ground level.
- (c) Apabila parking pallet telah berada pada kedudukan "sedia ", front gate akan terbuka secara automatik.
- (d) Kereta akan dipandu masuk ke parking pallet yang telah disediakan.
- (e) Operator akan memasukkan maklumat 'selesai" pada Operation control Board dan arahan kepada front gate supaya tertutup semula.

Merupakan suatu system pengurusan meletak kereta secara automatic yang bergerak secara selari dalam gerakan/ mendatar/ menegak dan dikawal oleh satu control board.

Lifting/parallel motion by driving method ( driving up and down with roller chain by electric motor with speed reducing device or traversing with roller chain by electric motor with speed reducing device) and electric method (0.2-2.2kw ) furnished with brake( 3 phase 200/220V 50-60Hz).

They include bucket lifts for pulverised or granular materials, platform elevators for crates, parcels, etc., finger-tray elevators for sacks, barrels, bales of straw, sheaves, etc., and continuous multiple-cage lifts for passengers, etc.*
