

## AKTA KASTAM 1967

### PERINTAH KASTAM (LARANGAN MENGENAI EKSPORT) (PINDAAN) (NO. ) 2010

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [*Akta 235* ], Menteri membuat perintah yang berikut:

#### **Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Eksport) (Pindaan) (No. ) 2010**.
- (2) Perintah ini mula berkuat kuasa pada 1 November 2010.

#### **Pindaan Jadual**

2. Perintah Kastam (Larangan Mengenai Eksport) 2008 [*P.U. (A) 87/2008* ] dipinda –

(1) dalam Jadual Pertama, dengan memasukkan selepas butiran 3 dan butir-butir yang berhubungan dengan butiran itu butiran yang berikut:

(1) <i>Item No.</i>	(2) <i>Description of Goods</i>	(3) <i>Destination</i>
“ 4.	All kinds of natural sands excluding silica sands and filter sands	All countries ”; dan

(2) dalam Jadual Kedua –

(a) berhubung dengan butiran 17 dalam ruang (3), dengan memotong subkepala 2505.10 000; dan

(b) dengan menggantikan butiran 18 dan butir-butir yang berhubungan dengan butiran itu dengan butiran yang berikut:

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF EXPORTS) (AMENDMENT) (No. ) ORDER 2010

In exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [*Act 235* ], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Exports) (Amendment) (No. ) Order 2010**.
- (2) This Order comes into operation on 1 November 2010.

**Amendment of Schedule**

2. The Customs Duties (Prohibition of Exports) 2008 [*P.U. (A) 87/2008* ] is amended –

- (1) in the First Schedule, by inserting after item 3 and the particulars relating to the item the following item:

(1) <i>Item No.</i>	(2) <i>Description of Goods</i>	(3) <i>Destination</i>
“ 4.	All kinds of natural sands excluding silica sands and filter sands	All countries ” ; and

- (2) in the Second Schedule –

(a) in relation to item 17 in column (3), by deleting subheading 2505.10 000; and

(b) by substituting for item 18 and the particulars relating to the item the following item:

(1) <i>Item No.</i>	(2) <i>Description of Goods</i>	(3) <i>Heading/Subheading</i>	(4) <i>Ministry/Department/Statutory Body Issuing Licence</i>
“ 18.	Natural sands:		Ministry of Natural Resources and Environment ”
(a)	Silica sands only excluding quartz sand	2505.10 000	
(b)	Filter sands only	2505.90 000
