CUSTOMS (VALUES OF IMPORTED COMPLETELY BUILT-UP MOTOR VEHICLES) (NEW)
(AMENDMENT) (NO. 2) ORDER 2013

IN exercise of the powers conferred by section 12 of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Values of Imported Completely Built-Up Motor Vehicles) (New) (Amendment) (No. 2) Order 2013**.

(2) This Order comes into operation on 12 December 2013.

Amendment of Schedule

2. The Customs (Values of Imported Completely Built-Up Motor Vehicles) (New) Order 2006 [*P.U. (A) 108/2006*] is amended in the Schedule—

(a) in column (2)—

(i) in relation to No. 151I by substituting for the figures “38,970” the figures “24,502”;
