AKTA DUTI TIMBAL BALAS DAN ANTI-LAMBAKAN 1993 DAN AKTA KASTAM 1967

PERINTAH KASTAM (DUTI ANTI-LAMBAKAN) 2019 (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh seksyen 25 Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) 2019 (Pindaan) 2022**.

(2) Perintah ini mula berkuat kuasa pada 1 Jun 2022.

**Pindaan perenggan 4**

2. Perintah Kastam (Duti-Anti Lambakan) 2019 [*P.U. (A) 69/2019*], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam perenggan 4, dalam subperenggan (1), dengan menggantikan perkataan “Perintah Duti Kastam 2017 [*P.U. (A) 5/2017*]” dengan perkataan “Perintah Duti Kastam 2022 [*P.U. (A) 114/2022*]”.

**Pindaan Jadual**

3. Jadual kepada Perintah ibu dipinda dalam ruang (1)—

(a) dengan menggantikan subkepala “7210.49.12 00,” dengan subkepala “7210.49.14 00, 7210.49.17 00,”;

(b) dengan menggantikan subkepala “7210.49.13 00,” dengan subkepala “7210.49.15 00, 7210.49.18 00,”;

(c) dengan menggantikan subkepala “7210.49.19 00,” dengan subkepala “7210.49.16 00, 7210.49.19 00,”; dan

(d) dengan menggantikan subkepala “7225.92.90 00,” dengan subkepala “7225.92.20 00, 7225.92.90 00,”.

## COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967

## CUSTOMS (ANTI-DUMPING DUTIES) 2019 (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by section 25 of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504] and subsection 11(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) 2019 (Amendment) Order 2022**.

(2) This Order comes into operation on 1 June 2022.

**Amendment of paragraph 4**

2. The Customs (Anti-Dumping Duties) Order 2019 [P.U. (A) 69/2019], which is referred to as the “principal Order” in this Order, is amended in paragraph 4, in subparagraph (1), by substituting for the words “Customs Duties Order 2017 [P.U. (A) 5/2017]” the words “Customs Duties Order 2022 [P.U. (A) 114/2022]”.

**Amendment of Schedule**

2. The Schedule to the principal Order is amended in column (1)—

(a) by substituting for subheading “7210.49.12 00,” subheadings “7210.49.14 00, 7210.49.17 00,”;

(b) by substituting for subheading “7210.49.13 00,” subheadings “7210.49.15 00, 7210.49.18 00,”;

(c) by substituting for subheading “7210.49.19 00,” subheadings “7210.49.16 00, 7210.49.19 00,”; and

(d) by substituting for subheading “7225.92.90 00,” subheadings “7225.92.20 00, 7225.92.90 00,”.
