#### **CUSTOMS ACT 1967**

## CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

#### Citation and commencement

- 1. (1) This order may be cited as the **Customs (Prohibition of Imports)** (Amendment) Order 2022.
  - (2) This Order comes into operation on 10 January 2022.

#### **Amendment of Fourth Schedule**

- 2. The Customs (Prohibition of Imports) Order 2017 [*P.U. (A) 103/2017*], is amended in the Fourth Schedule, in Part II—
