### CUSTOMS ACT 1967

#### CUSTOMS (VALUES OF IMPORTED COMPLETELY BUILT-UP MOTOR VEHICLES) (NEW) (AMENDMENT) ORDER 2009

IN exercise of the powers conferred by section 12 of the Customs Act 1967 [Act 235], the Minister makes the following order:

#### **Citation and commencement**

1. (1) This order may be cited as the **Customs (Values of Imported Completely Built-Up Motor Vehicles) (New) (Amendment) Order 2009**.

### FOOD ACT 1983

#### CONTROL OF TOBACCO PRODUCT (AMENDMENT) REGULATIONS 2009

IN exercise of the powers conferred by section 36 of the Food Act 1983 [Act 281], the Minister makes the following regulations:

**Citation**

1. These regulations may be cited as the **Control of Tobacco Product (Amendment) Regulations 2009**.

**Amendment of regulation 7**

2. The Control of Tobacco Product Regulations 2004 [P.U. (A) 324/2004], which are referred to as the “principal Regulations” in these Regulations, are amended in regulation 7—

- (a) in paragraph (a), by inserting after the word “gift” the words “or being sold together”;
- (b) in paragraph (b), by inserting after the word “gift” the words “or being sold together”;

- (c) in paragraph (c), by inserting after the word “gift” the words “or being sold together”; and
- (d) in subregulation (4), by inserting after the word “years” the word “or to both”.

**Amendment of regulation 23**

3. Subregulation 23(1) of the principal Regulations is amended by inserting after the word “subregulations” the word “7(1),”.
