PERINTAH EKSAIS (PENGECUALIAN DARIPADA PELESENAN) (PINDAAN) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 20(2) Akta Eksais 1976 [*Akta 176*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Eksais (Pengecualian daripada Pelesenan) (Pindaan) 2022**.

(2) Perintah ini mula berkuat kuasa pada 1 November 2022.

**Pindaan perenggan 2**

2. Perintah Eksais (Pengecualian Daripada Pelesenan) 2019 [*P.U. (A) 155/2019*] dipinda dalam perenggan 2—

(a) dalam takrif “kepala 20.09”, dengan menggantikan perkataan “Perintah Duti Kastam 2017 [*P. U. (A) 5/2017*]” dengan perkataan “Perintah Duti Kastam 2022 [*P.U. (A) 114/2022*]”; dan

(b) dalam takrif “kepala 22.02” dan “Bab 4”, dengan menggantikan perkataan “Perintah Duti Kastam 2017” dengan perkataan “Perintah Duti Kastam 2022”.

**Pindaan Jadual**

3. Perintah Eksais (Pengecualian Daripada Pelesenan) 2019 [*P.U. (A) 155/2019*] dipinda dalam Jadual dengan memasukkan selepas butiran 5 dan butir-butir yang berhubungan dengannya butiran dan butir-butir berikut:

“6. Pengilang yang mengilang penyediaan pracampuran di bawah subkepala 1806.10.00 00, 1806.90.30 00, 1806.90.90 00, 1901.90.32 00, 1901.90.39 00, 1901.90.41 00, 1901.90.49 00, 1901.90.99 00, 2101.12.10 00, 2101.12.91 00, 2101.12.92 00,

2101.12.99 00, 2101.20.30 00, 2101.20.90 00, 2106.90.53 00 dan 2106.90.59 00 Jadual Pertama kepada Perintah Duti Kastam 2022 yang jumlah kandungan gulanya ialah 33.3 gram tiap-tiap 100 gram (33.3g/100g) atau kurang.”

EXCISE ACT 1976

EXCISE (EXEMPTION FROM LICENSING) (AMENDMENT) ORDER 2022

IN exercise of the powers conferred by subsection 20(2) of the Excise Act 1976 [Act 176], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Excise (Exemption from Licensing) (Amendment) Order 2022**.

(2) This Order comes into operation on 1 November 2022.

**Amendment of paragraph 2**

2. The Excise (Exemption From Licensing) Order 2019 [P.U. (A) 155/2019] is amended in paragraph 2—

(a) in the definition of “heading 20.09”, by substituting for the words “Customs Duties Order 2017 [P.U. (A) 5/2017]” the words “Customs Duties Order 2022 [P.U. (A) 114/2022]”; and

(b) in the definitions of “heading 22.02” and “Chapter 4”, by substituting for the words “Customs Duties Order 2017” the words “Customs Duties Order 2022”.

**Amendment of Schedule**

3. The Excise (Exemption From Licensing) Order 2019 [P. U. (A) 155/2019] is amended in the Schedule by inserting after item 5 and the particulars relating to it the following item and particulars:

“6. Manufacturers who manufacture premix preparation under the subheadings 1806.10.00 00, 1806.90.30 00, 1806.90.90 00, 1901.90.32 00, 1901.90.39 00, 1901.90.41 00, 1901.90.49 00, 1901.90.99 00, 2101.12.10 00, 2101.12.91 00, 2101.12.92 00,

2101.12.99 00, 2101.20.30 00, 2101.20.90 00, 2106.90.53 00  
and 2106.90.59 00 of the First Schedule to the Customs Duties  
Order 2022 of which the total sugars content is 33.3 grams  
per 100 grams (33.3g/100g) or less.”
