PERINTAH EKSAIS (PENGECUALIAN DARIPADA PELESENAN) (PINDAAN) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 20(2) Akta Eksais 1976 [Akta 176], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Eksais (Pengecualian daripada Pelesenan) (Pindaan) 2025**.

(2) Perintah ini mula berkuat kuasa pada 1 November 2025.

Pindaan perenggan 2

2. Perintah Eksais (Pengecualian daripada Pelesenan) 2019 [P.U. (A) 155/2019], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam perenggan 2—

(a) dalam takrif “kepala 20.09”, dengan menggantikan perkataan “Perintah Duti Kastam 2022 [P.U. (A) 114/2022]” dengan perkataan “Perintah Duti Kastam 2025 [P.U. (A) 384/2025]”;

(b) dalam takrif “kepala 22.02”, dengan menggantikan perkataan “Perintah Duti Kastam 2022” dengan perkataan “Perintah Duti Kastam 2025”; dan

(c) dalam takrif “Bab 4”, dengan menggantikan perkataan “Perintah Duti Kastam 2022” dengan perkataan “Perintah Duti Kastam 2025”.

Pindaan Jadual

3. Perintah ibu dipinda dalam Jadual—

(a) dalam butiran 6, dengan menggantikan perkataan “Perintah Duti Kastam 2022” dengan perkataan “Perintah Duti Kastam 2025”; dan

(b) dalam butiran 7, dengan menggantikan perkataan “Perintah Duti Kastam 2022” dengan perkataan “Perintah Duti Kastam 2025”.

EXCISE ACT 1976

EXCISE (EXEMPTION FROM LICENSING) (AMENDMENT) ORDER 2025

IN exercise of the powers conferred by subsection 20(2) of the Excise Act 1976 [*Act 176*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Excise (Exemption from Licensing) (Amendment) Order 2025**.

(2) This Order comes into operation on 1 November 2025.

Amendment of paragraph 2

2. The Excise (Exemption from Licensing) Order 2019 [*P.U. (A) 155/2019*], which is referred to as the “principal Order” in this Order, is amended in paragraph 2—

(a) in the definition of “heading 20.09”, by substituting for the words “Customs Duties Order 2022 [*P.U. (A) 114/2022*]” the words “Customs Duties Order 2025 [*P.U. (A) 384/2025*]”;

(b) in the definition of “heading 22.02”, by substituting for the words “Customs Duties Order 2022” the words “Customs Duties Order 2025”; and

(c) in the definition of “Chapter 4”, by substituting for the words “Customs Duties Order 2022” the words “Customs Duties Order 2025”.

Amendment of Schedule

3. The principal Order is amended in the Schedule—

- (a)* in item 6, by substituting for the words “Customs Duties Order 2022” the words “Customs Duties Order 2025”; and
- (b)* in item 7, by substituting for the words “Customs Duties Order 2022” the words “Customs Duties Order 2025”.
