FREE ZONES ACT 1990

FREE ZONES (AMENDMENT OF FIRST SCHEDULE) NOTIFICATION (NO. 2) 2020

IN exercise of the powers conferred by subsection 10(2) of the Free Zones Act 1990 [Act 438], the Minister makes the following notification:

Citation and commencement

1. (1) This notification may be cited as the **Free Zones (Amendment of First Schedule) Notification (No. 2) 2020.**

(2) This Notification comes into operation on 20 October 2020.

Amendment of First Schedule

2. The First Schedule to the Free Zones Act 1990 is amended in item 10 by substituting for the words “*Gazette* Plan 1207 and *Gazette* Plan 1981” the words “*Gazette* Plan 1207, *Gazette* Plan 1981 and *Gazette* Plan 3004”.
