PERINTAH CUKAI JUALAN (PENGECCUALIAN) (PINDAAN) (NO. 3) 2012

PADA menjalankan kuasa yang diberikan oleh seksyen 8 Akta Cukai Jualan 1972 [Akta 64], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Cukai Jualan (Pengecualian) (Pindaan) (No. 3) 2012**.

(2) Perintah ini mula berkuat kuasa pada 26 Jun 2012.

2. Perintah Cukai Jualan (Pengecualian) 2008 [P.U. (A) 91/2008] dipinda dalam Jadual B, berhubung dengan butiran 78, dalam ruang (2) dengan menggantikan perenggan (vi) dengan perenggan yang berikut:

“(vi) Boustead Penang Shipyard Sdn. Bhd. (dahulunya dikenali sebagai Penang Shipbuilding & Construction Sdn. Bhd.);”.

SALES TAX ACT 1972

SALES TAX (EXEMPTION) (AMENDMENT) (NO. 3) ORDER 2012

IN exercise of the powers conferred by section 8 of the Sales Tax Act 1972 [*Act 64*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Sales Tax (Exemption) (Amendment) (No. 3) Order 2012**.

(2) This Order comes into operation on 26 June 2012.

Amendment of Schedule B

2. The Sales Tax (Exemption) Order 2008 [*P.U. (A) 91/2008*] is amended in Schedule B, in relation to item 78, in column (2) by substituting for paragraph (vi) the following paragraph:

“(vi) Boustead Penang Shipyard Sdn. Bhd. (formerly known as Penang Shipbuilding & Construction Sdn. Bhd.);”.
