Keterangan :

Barangan yang dinamakan sebagai *Car Parking Management System* merupakan sejenis sistem untuk mengendalikan tempat meletak kenderaan secara automatik. Ia dilengkapi dengan *Ticket Dispenser*, *Ticket Reader*, *Barrier Gate*, *Automatic Pay Station* dan *Central Computer*. Kuantiti yang diperlukan bergantung kepada saiz tempat meletak kenderaan yang berkenaan tetapi secara minimanya satu unit *ticket dispenser* diperlukan di pintu masuk, satu *Ticket Reader* di pintu keluar, satu unit *Automatic Pay Station* dilokasi yang ditetapkan dan satu unit *Central Computer* di *Car Park Office*.

Sistem meletak kenderaan ini dilengkapi dengan gabungan mesin-mesin yang mempunyai fungsi tersendiri seperti berikut :

Ticket Dispenser - Mesin untuk mengeluarkan tiket untuk masuk ke tempat meletak kenderaan

Auto Pay Station - Membuat pengiraan dan pengesahan bayaran letak kereta secara otomatis mengikut tempoh kenderaan diletakkan.

Ticket reader - Mesin untuk penyerahan tiket yang telah dijelaskan untuk pengesahan dan untuk keluar daripada tempat meletak kenderaan.

Barrier Gate - Palang yang akan terbuka secara automatik setelah tiket dikeluarkan oleh *Ticket Dispenser* dan setelah pengesahan bayaran meletak kenderaan telah dijelaskan oleh *Ticket Reader*.

Central Computer - Memantau dan mengawal hubungan komunikasi antara komponen-komponen di atas untuk membentuk satu sistem kawalan meletak kenderaan secara berpusat

Memandangkan barang ini mengandungi gabungan mesin yang lengkap untuk pengendalian sebuah tempat meletak kenderaan, maka ia menepati keterangan *functional unit* mengikut liputan di dalam *Chapter Note 4, Section XVI, EN* muka surat XVI-2 dan keterangan di muka surat XVI-7 seperti berikut :

**MACHINERY AND MECHANICAL APPLIANCES;
ELECTRICAL EQUIPMENT; PARTS THEREOF; SOUND
RECORDERS AND REPRODUCERS, TELEVISION IMAGE
AND SOUND RECORDERS AND REPRODUCERS, AND
PARTS AND ACCESSORIES OF SUCH ARTICLES**

4.- *Where a machine (including a combination of machines) consists of individual components (whether separate or interconnected by piping, by transmission devices, by electric cables or by other devices) intended to contribute together to a clearly defined function covered by one of the headings in Chapter 84 or Chapter 85, then the whole falls to be classified in the heading appropriate to that function.*

(VII) FUNCTIONAL UNITS
(Section Note 4)

This Note applies when a machine (including a combination of machines) consists of separate components which are intended to contribute together to a clearly defined function covered by one of the headings in Chapter 84 or, more frequently, Chapter 85. The whole then falls to be classified in the heading appropriate to that function, whether the various components (for convenience or other reasons) remain separate or are interconnected by piping (carrying air, compressed gas, oil, etc.), by devices used to transmit power, by electric cables or by other devices.

For the purposes of this Note, the expression “intended to contribute together to a clearly defined function” covers only machines and combinations of machines essential to the performance of the function specific to the functional unit as a whole, and thus excludes machines or appliances fulfilling auxiliary functions and which do not contribute to the function of the whole.

Barangan ini terdiri daripada mesin-mesin yang mempunyai fungsinya yang tersendiri (*individual function*). Mesin yang mempunyai *individual function* mendapat liputan di dalam EN muka surat XVI-8479-1 seperti berikut :

84.79 -Machines and mechanical appliances having individual functions, not specified or included elsewhere in this Chapter.

.....

8479.89 - -Other

This heading is restricted to machinery having individual functions, which :

(a) Is not excluded from this Chapter by the operation of any Section or Chapter Note.

and

(b) Is not covered more specifically by a heading in any other Chapter of the Nomenclature.

and

(c) Cannot be classified in any other particular heading of this Chapter since :

(i) No other heading covers it by reference to its method of functioning, description or type.

and


(ii) No other heading covers it by reference to its use or to the industry in which it is employed.

or

(iii) It could fall equally well into two (or more) other such headings (general purpose machines).

Berdasarkan kepada fakta-fakta diatas, Panel Penetapan Penjenisan berpendapat barang ini sesuai dipenjeniskan mengikut **General Interpretation Rule 1 & 6** di bawah kod tarif **8479.89.900** sebagai **machine having individual function, not specified or included elsewhere in Chapter 84..**
