The subject imports are printed copies of various paintings which have been matted, mounted and permanently sealed in wooden frames of differing weights and sizes. The framed prints are intended for use as a decorative item and cannot be separated without causing substantial damage

Classification of the subject merchandise is governed by essential character. According to the ENs, when "the essential character of the whole is given by the pictures," framed paintings are classifiable under heading 4911

These factors make clear that the printed pictures impart the essential character. the frames and prints have been permanently sealed together and must be displayed together....
