AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) (NO.2) 2018

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) (Pindaan) (No. 2) 2018.**

(2) Perintah ini mula berkuat kuasa pada 18 Julai 2018.

**Pindaan Jadual**

2. Perintah Duti Kastam (Pengecualian) 2017 [P.U. (A) 445/2017] dipinda dalam Bahagian I Jadual, berhubung dengan butiran 67, dalam ruang (2),—

(a) dengan menggantikan perenggan (xxiii) dengan perenggan yang berikut:

“(xxiii) EnQuest Petroleum Production Malaysia Ltd. (dahulunya dikenali sebagai EQ Petroleum Production Ltd.);”; dan

(b) dengan memasukkan selepas perenggan (xxvi) perenggan yang berikut:

“(xxvii) SEA Hibiscus Sdn. Bhd.”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 2) ORDER 2018

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 2) Order 2018**.

(2) This Order comes into operation on 18 July 2018.

**Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in Part I of the Schedule, in relation to item 67, in column (2),—

(a) by substituting for paragraph (xxiii) the following paragraph:

“(xxiii) EnQuest Petroleum Production Malaysia Ltd. (formerly known as EQ Petroleum Production Ltd.);”; and

(b) by inserting after paragraph (xxvi) the following paragraph:

“(xxvii) SEA Hibiscus Sdn. Bhd.”.
