AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) (NO. 4) 2018

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) (Pindaan) (No. 4) 2018**.

(2) Perintah ini mula berkuat kuasa pada 31 Oktober 2018.

**Pindaan Jadual**

2. Perintah Duti Kastam (Pengecualian) 2017 [*P.U. (A) 445/2017*] dipinda dalam Bahagian I Jadual, berhubung dengan butiran 68, dalam ruang 2,—

(a) dalam perenggan (viii), dengan memasukkan selepas perkataan “Bhd.” koma bernoktah; dan

(b) dengan memasukkan selepas perenggan (viii) perenggan yang berikut:

“(ix) OceanMight Sdn. Bhd.”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 4) ORDER 2018

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 4) Order 2018**.

(2) This Order comes into operation on 31 October 2018.

**Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in Part I of the Schedule, in relation to item 68, in column (2),—

(a) in paragraph (viii), by inserting after the word “Bhd.” a semicolon; and

(b) by inserting after paragraph (viii) the following paragraph:

“(ix) OceanMight Sdn. Bhd.”.
