PERINTAH KASTAM (DUTI ANTI-LAMBAKAN) 2019 (PINDAAN) 2020

PADA menjalankan kuasa yang diberikan oleh seksyen 25 Akta Duti Timbal Balas dan Anti-Lambakan 1993 [Akta 504] dan subseksyen 11(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) 2019 (Pindaan) 2020.**

(2) Perintah ini disifatkan telah mula berkuat kuasa pada 8 Mac 2019 dan hendaklah terus berkuat kuasa hingga 7 Mac 2024.

**Pindaan Jadual**

2. Jadual kepada Perintah Kastam (Duti Anti-Lambakan) 2019 [P.U. (A) 69/2019] dipinda—

(a) dalam ruang (4), dengan menggantikan perkataan “BX Steel POSCO Cold Rolled Steel Co., Ltd.” dengan perkataan “BX Steel POSCO Cold Rolled Sheet Co., Ltd.”; dan

(b) dalam ruang (5)—

(i) berhubung dengan “Bengang Steel Plates Co., Ltd.”, dengan menggantikan perkataan “10.62%” dengan perkataan “Nil”; dan

(ii) berhubung dengan “BX Steel POSCO Cold Rolled Sheet Co., Ltd.”, dengan menggantikan perkataan “5.47%” dengan perkataan “Nil”.

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993  
AND  
CUSTOMS ACT 1967

CUSTOMS (ANTI-DUMPING DUTIES) ORDER 2019 (AMENDMENT) 2020

IN exercise of the powers conferred by section 25 of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) Order 2019 (Amendment) 2020**.

(2) This Order is deemed to have come into operation on 8 March 2019 and shall continue to be in operation until 7 March 2024.

**Amendment of Schedule**

2. The Schedule to the Customs (Anti-Dumping Duties) Order 2019 [P.U. (A) 69/2019] is amended—

(a) in column (4), by substituting for the words “BX Steel POSCO Cold Rolled Steel Co., Ltd.” the words “BX Steel POSCO Cold Rolled Sheet Co., Ltd.”; and

(b) in column (5)—

(i) relation to “Bengang Steel Plates Co., Ltd.”, by substituting for the words “10.62%” the word “Nil”; and

(ii) in relation to “BX Steel POSCO Cold Rolled Sheet Co., Ltd.”, by substituting for the words “5.47%” the word “Nil”.
