- PTT can only be cancelled if no declaration done by using that PTT, or, PTT Registration Number not yet used in any declaration (declaration still in *Draft Created* status)
- If declaration has been done, PTT registration no longer can be cancelled. If want to, PTT registration need to be cancelled first.
