 If you are registered by 1st April, 2015, you can claim a special refund of sales tax paid, or an amount paid on the sales invoice on selected taxable goods, (under the Sales Tax Act 1972) which you hold on hand as at 1st April 2015 and acquired before such date. If you are not liable to be registered on 1st April 2015, you are not eligible for a special refund. Those goods are to be used for the purposes of making taxable supplies This service allows you to submit a special refund claim to request the amount of sales tax you would like refunded. You can only apply for a special refund through TAP. Your session will expire after 15 minutes of inactivity 	 You must determine the total amount of sales tax or special refund you would like to have refunded. Prepare and submit an audit certificate signed by a chartered account if the amount being claimed is less than RM10,000.00. Prepare and submit an audit certificate signed by an approved company auditor under Section 8 of the Companies Act 1965 if the amount being claimed is equal to or greater than RM10,000. You must have records to substantiate your claim. 	 Print the confirmation page for your records. Click on the request tab to check the status of your claim. If you been refunded and subsequently return the same goods to your supplier, you must account for the special refund as your output tax in your return for the taxable period in which the goods were returned.
