COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993

CUSTOMS (ANTI-DUMPING DUTIES) (EXPEDITED REVIEW) (REVOCATION) ORDER 2025

IN exercise of the powers conferred by subsection 11(1) of the Customs Act 1967 [Act 235] read together with subsection 28B(1) of the Countervailing and Anti-Dumping Duties Act 1993 [Act 504], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Expedited Review) (Revocation) Order 2025**.

(2) This Order comes into operation on 15 June 2025.
