PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) 2025

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) ORDER 2025

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) Order 2025**.

(2) This Order comes into operation on 1 February 2025.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in the Schedule, in Part I, in relation to item 68, in column (2), in subitem (vi), by substituting for the words “Syarikat Perbadanan Urusan Kejuruteraan dan Limbungan Brooke (Brooke Dockyard & Engineering Works Corporation) Kuching, Sarawak” the words “Brooke Holding Sdn. Bhd. (formerly known as Syarikat Perbadanan Urusan Kejuruteraan dan Limbungan Brooke (Brooke Dockyard & Engineering Works Corporation) Kuching, Sarawak)”.
