FREE ZONES ACT 1990

FREE ZONES (AMENDMENT OF FIRST SCHEDULE) (NO. 3) NOTIFICATION 2023

IN exercise of the powers conferred by subsection 10(2) of the Free Zones Act 1990 [Act 438], the Minister makes the following notification:

**Citation and commencement**

1. (1) This notification may be cited as the **Free Zones (Amendment of First Schedule) (No. 3) Notification 2023**.

(2) This Notification comes into operation on 15 August 2023.

**Amendment of First Schedule**

2. The First Schedule to the Free Zones Act 1990 is amended in item 10 by substituting for the words "*Gazette Plan 1207, Gazette Plan 1981 and Gazette Plan 3004*" the words "*Gazette Plan 1207, Gazette Plan 1981, Gazette Plan 3004 and Gazette Plan 1376*".
