PERINTAH KASTAM (LARANGAN MENGENAI EKSPORT) (PINDAAN) 2021

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Eksport) (Pindaan) 2021**.

(2) Perintah ini mula berkuat kuasa pada 1 April 2021.

Pindaan Jadual Kedua

2. Perintah Kastam (Larangan Mengenai Eksport) 2017 [*P.U. (A) 102/2017*] dipinda dalam Jadual Kedua—

(a) berhubung dengan butiran 7—

- (i) dalam ruang (5), dengan menggantikan perkataan “Ministry of Natural Resources and Environment” dengan perkataan “Ministry of Energy and Natural Resources”; dan
- (ii) dengan memasukkan selepas subbutiran (6) dalam ruang (2) dan butir-butir yang bersetentangan dengannya dalam ruang (3) subbutiran dan butir-butir yang berikut:

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF EXPORTS) (AMENDMENT) ORDER 2021

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Exports) (Amendment) Order 2021**.

(2) This Order comes into operation on 1 April 2021.

Amendment of Second Schedule

2. The Customs (Prohibition of Exports) Order 2017 [P.U. (A) 102/2017] is amended in the Second Schedule—

(a) in relation to item 7—

(i) in column (5), by substituting for the words “Ministry of Natural Resources and Environment” the words “Ministry of Energy and Natural Resources”; and

(ii) by inserting after subitem (6) in column (2) and the particulars against it in column (3) the following subitem and particulars:

(2) <i>Description of Goods</i>	(3) <i>Chapter/ Heading/ Subheading</i>
“(7) Rare-earth metal, scandium and yttrium, whether or not intermixed or interalloyed	2805.30.00 00

(8) Cerium compounds and other compounds, inorganic or organic, of rare-earth metals, of yttrium or of scandium or of mixtures of these metals	2846.10.00 00 2846.90.00 00”; and

(b) in relation to items 8 and 9, in column (5), by substituting for the words “Ministry of Natural Resources and Environment” the words “Ministry of Energy and Natural Resources”.
