CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF EXPORTS) (AMENDMENT) (NO. 2) ORDER 2020

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Exports) (Amendment)(No.2) Order 2020**.

(2) This Order comes into operation on 20 March 2020.

Amendment of Third Schedule

2. The Customs (Prohibition of Exports) Order 2017 [*P.U. (A) 102/2017*] is amended in Part I of the Third Schedule by inserting after item 43 and the particulars relating to it the following item and particulars:

Nama

1. Perintah ini bolehlah dinamakan **Perintah Kawalan Harga dan Antipencatutan (Penentuan Harga Maksimum) (No. 2) 2020**.

Harga borong maksimum

2. Harga borong maksimum bagi barangan harga terkawal yang dinyatakan dalam ruang (1) Jadual ditentukan sebagaimana yang dinyatakan dalam ruang (2).

Harga runcit maksimum

PRICE CONTROL AND ANTI-PROFITEERING ACT 2011

PRICE CONTROL AND ANTI-PROFITEERING (DETERMINATION OF
MAXIMUM PRICE) (NO. 2) ORDER 2020

IN exercise of the powers conferred by section 4 of the Price Control and Anti-Profiteering Act 2011 [*Act 723*], the Controller, with the approval of the Minister, makes the following order:

Citation

1. This order may be cited as the **Price Control and Anti-Profiteering (Determination of Maximum Price) (No. 2) Order 2020**.

Maximum wholesale price

2. The maximum wholesale price for the price-controlled goods specified in column (1) of the Schedule is determined as specified in column (2).

Maximum retail price

3. The maximum retail price for the price-controlled goods specified in column (1) of the Schedule is determined as specified in column (3).

Revocation

4. The Price Control (Fixing of Maximum Price) (No. 2) Order 2009 [*P.U. (A) 309/2009*] is revoked.
