CUSTOMS DUTIES (GOODS UNDER THE MALAYSIA-UNITED ARAB EMIRATES
COMPREHENSIVE ECONOMIC PARTNERSHIP AGREEMENT)
(AMENDMENT) ORDER 2025

IN exercise of the powers conferred by subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Goods under the Malaysia-United Arab Emirates Comprehensive Economic Partnership Agreement) (Amendment) Order 2025**.

(2) This Order comes into operation on 1 September 2025.

Amendment of paragraph 1

2. The Customs Duties (Goods under the Malaysia-United Arab Emirates Comprehensive Economic Partnership Agreement) Order 2025 [*P.U. (A) 238/2025*] is amended in subparagraph 1(2) by substituting for the words “1 September 2025” the words “1 October 2025”.
