PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) (NO. 3) 2023

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) (NO. 3) ORDER 2023

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) (No. 3) Order 2023**.

(2) This Order comes into operation on 18 August 2023.

**Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in the Schedule, in Part I, in column (2), in relation to subitem 67(xvii), by substituting for the words “MDC Oil & Gas (SK320) Ltd.” the words “Mubadala Energy (SK 320) Ltd.”.
