## AKTA KASTAM 1967

### PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO. 2) 2023

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

#### **Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 2) 2023**.  
  
(2) Perintah ini mula berkuat kuasa pada 1 Januari 2024.

#### **Pindaan Jadual Pertama**

2. Perintah Kastam (Larangan Mengenai Import) 2023 [P.U. (A) 117/2023], yang disebut “Perintah ibu” dalam Perintah ini, dipinda dalam Jadual Pertama, berhubung dengan butiran 13, dalam ruang (2), dengan menggantikan perkataan “terbutaline or formoterol” dengan perkataan “terbutaline, formoterol or polymyxin including polymyxin B and polymyxin E (colistin)”.

#### **Pindaan Jadual Kedua**

3. Perintah ibu dipinda dalam Jadual Kedua, dalam Bahagian I, berhubung dengan butiran 13, dengan memotong subbutiran (1) dan butir-butir yang berhubungan dengannya.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 2) ORDER 2023

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 2) Order 2023**.

(2) This Order comes into operation on 1 January 2024.

**Amendment of First Schedule**

2. The Customs (Prohibition of Imports) Order 2023 [P.U. (A) 117/2023], which is referred to as the “principal Order” in this Order, is amended in the First Schedule, in relation to item 13, in column (2), by substituting for the words “terbutaline or formoterol” the words “terbutaline, formoterol or polymyxin including polymyxin B and polymyxin E (colistin)”.

**Amendment of Second Schedule**

3. The principal Order is amended in the Second Schedule, in Part I, in relation to item 13, by deleting subitem (1) and the particulars relating to it.
