PADA menjalankan kuasa yang diberikan oleh seksyen 28 Akta Duti Timbal Balas dan Anti-Lambakan 1993 [*Akta 504*] dan subseksyen 11(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Pentadbiran) (No. 3) 2021 (Pindaan) 2023**.

(2) Perintah ini berkuat kuasa bagi tempoh mulai 27 Jun 2023 hingga 8 Oktober 2026.

**Pindaan Jadual**

2. Perintah Kastam (Duti Anti-Lambakan) (Kajian Semula Pentadbiran) (No. 3) 2021 [*P.U. (A) 384/2021*] dipinda dalam Jadual, dalam ruang (3)—

(a) dengan memotong perkataan “Republik Korea” dan butir-butir yang berhubungan dengannya dalam ruang (4) dan (5); dan

(b) dengan memotong perkataan “Republik Sosialis Viet Nam” dan butir-butir yang berhubungan dengannya dalam ruang (4) dan (5).

COUNTERVAILING AND ANTI-DUMPING DUTIES ACT 1993 AND CUSTOMS ACT 1967

CUSTOMS (ANTI-DUMPING DUTIES) (ADMINISTRATIVE REVIEW) (NO. 3) 2021  
(AMENDMENT) ORDER 2023

IN exercise of the powers conferred by section 28 of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Anti-Dumping Duties) (Administrative Review) (No. 3) 2021 (Amendment) Order 2023**.

(2) This Order has effect for the period from 27 June 2023 to 8 October 2026.

**Amendment of Schedule**

2. The Customs (Anti-Dumping Duties) (Administrative Review) (No. 3) Order 2021 [*P.U. (A) 384/2021*] is amended in the Schedule, in column (3)—

(a) by deleting the words “Republic of Korea” and the particulars relating to it in columns (4) and (5); and

(b) by deleting the words “Socialist Republic of Viet Nam” and the particulars relating to it in columns (4) and (5).
