# CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) ORDER 2023

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

#### **Citation and commencement**

- 1. (1) This order may be cited as the **Customs Duties (Exemption)** (Amendment) Order 2023.
  - (2) This Order comes into operation on 9 March 2023.

### **Amendment of Schedule**

2. The Customs Duties (Exemption) Order 2017 [*P.U.* (*A*) 445/2017] is amended in the Schedule, in Part I by substituting for item 94 and the particulars relating to it the following item and particulars:
