AKTA KASTAM 1967

PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO.4) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

**Nama dan permulaan kuat kuasa**

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 4) 2022**.

(2) Perintah ini mula berkuat kuasa pada 15 Ogos 2022.

**Pindaan perenggan 6**

2. Perintah Kastam (Larangan Mengenai Import) 2017 [*P.U. (A) 103/2017*] dipinda dalam perenggan 6 dengan memasukkan selepas subperenggan (2) subperenggan yang berikut:

“(3) Larangan pengimportan ke dalam Malaysia dalam subperenggan (1) tidak terpakai bagi barang-barang yang dinyatakan dalam ruang (2) dan (3) Bahagian I Jadual Ketiga yang berada dalam kontena muatan penuh bagi pindah kapal di pelabuhan yang berstatus zon perdagangan bebas dan dikawal selia oleh agensi yang berikut:

(a) Jabatan Perkhidmatan Kuarantin dan Pemeriksaan Malaysia;

(b) Jabatan Perkhidmatan Veterinar;

(c) Jabatan Pertanian;

(d) Jabatan Perlindungan Hidupan Liar dan Taman Negara;

(e) Lembaga Kemajuan Ikan Malaysia;

- (f) Kawalselia Padi dan Beras;
- (g) Lembaga Pemasaran Pertanian Persekutuan; atau
- (h) Bahagian Keselamatan dan Kualiti Makanan di bawah Kementerian Kesihatan Malaysia.”.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 4) ORDER 2022

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

**Citation and commencement**

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 4) Order 2022**.

(2) This Order comes into operation on 15 August 2022.

**Amendment of paragraph 6**

2. The Customs (Prohibition of Imports) Order 2017 [*P.U. (A) 103/2017*] is amended in paragraph 6 by inserting after subparagraph (2) the following subparagraph:

“(3) The prohibition of import into Malaysia in subparagraph (1) is not applicable for goods specified in columns (2) and (3) of Part I of the Third Schedule which are in full container load (FCL) for transshipment at the free trade zone status port and regulated by the following agencies:

(a) Department of Malaysian Quarantine and Inspection Services;

(b) Department of Veterinary Services;

(c) Department of Agriculture;

(d) Department of Wildlife and National Park;

(e) Fisheries Development Authority of Malaysia;

- (f) Control of Paddy and Rice;
- (g) Federal Agricultural Marketing Authority; or
- (h) Food Safety and Quality Division under Ministry of Health.”.
