AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGECCUALIAN) 2017 (PINDAAN) (NO. 4) 2022

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengeccualian) 2017 (Pindaan) (No. 4) 2022**.

(2) Perintah ini mula berkuat kuasa pada 23 September 2022.

Pindaan Jadual

2. Perintah Duti Kastam (Pengeccualian) 2017 [*P.U. (A) 445/2017*] dipinda dalam Bahagian I Jadual, berhubung dengan butiran 67, dalam ruang (2)—

(a) dengan memasukkan koma bernoktah di hujung perenggan (xxix); dan

(b) dengan memasukkan selepas perenggan (xxix) perenggan yang berikut:

“(xxxi) Petra Energy Development Sdn Bhd”.

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) 2017 (AMENDMENT) (NO. 4) ORDER 2022

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) 2017 (Amendment) (No. 4) Order 2022**.

(2) This Order comes into operation 23 September 2022.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in Part I of the Schedule, in relation to item 67, in column (2)—

(a) by inserting semi colon at the end of paragraph (xxix); and

(b) by inserting after paragraph (xxix) the following paragraph:

“(xxxix) Petra Energy Development Sdn Bhd”.
