PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO. 3) 2025

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [*Akta 235*], Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 3) 2025**.

(2) Perintah ini mula berkuat kuasa pada 1 November 2025.

2. Perintah Kastam (Larangan Mengenai Import) 2023 [*P.U. (A) 117/2023*] dipinda dalam perenggan 12 dengan menggantikan perkataan “Perintah Duti Kastam 2022 [*P.U. (A) 114/2022*]” dengan perkataan “Perintah Duti Kastam 2025 [*P.U. (A) 384/2025*]”.

CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO. 3) ORDER 2025

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 3) Order 2025**.

(2) This Order comes into operation on 1 November 2025.

Amendment of paragraph 12

2. The Customs (Prohibition of Imports) Order 2023 [*P.U. (A) 117/2023*] is amended in paragraph 12 by substituting for the words “Customs Duties Order 2022 [*P.U. (A) 114/2022*]” the words “Customs Duties Order 2025 [*P.U. (A) 384/2025*]”.
