CUSTOMS (ANTI-DUMPING DUTIES) (NO. 2) (EXTENSION OF OPERATION) ORDER 2024

IN exercise of the powers conferred by section 25 of the Countervailing and Anti-Dumping Duties Act 1993 [*Act 504*] read together with subsection 28(7) of the Act and subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

1. This order may be cited as the **Customs (Anti-Dumping Duties) (No. 2) (Extension of Operation) Order 2024**.
