AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PANGKOR) 2025

PADA menjalankan kuasa yang diberikan oleh perenggan 163R(1)(a) Akta Kastam 1967 [Akta 235] dibaca bersama-sama perenggan 163S(b) Akta, Menteri membuat perintah yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pangkor) 2025**.
- (2) Perintah ini mula berkuat kuasa pada 1 November 2025.

Duti import

2. Duti import hendaklah dilevi atas dan dibayar oleh pengimport berkenaan dengan barang-barang yang dinyatakan dalam Jadual yang diimport masuk ke dalam Pangkor atau diangkut dari kawasan utama kastam ke Pangkor pada kadar duti import yang dinyatakan dalam ruang (5) Jadual Pertama kepada Perintah Duti Kastam 2025 [P.U. (A) 384/2025].

Pembatalan

3. Perintah Duti Kastam (Pangkor) 2019 [P.U. (A) 413/2019] dibatalkan.

CUSTOMS ACT 1967

CUSTOMS DUTIES (PANGKOR) ORDER 2025

IN exercise of the powers conferred by paragraph 163R(1)(a) of the Customs Act 1967 [Act 235] read together with paragraph 163S(b) of the Act, the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Pangkor) Order 2025**.

(2) This Order comes into operation on 1 November 2025.

Import duty

2. Import duty shall be levied on and paid by the importer in respect of the goods specified in the Schedule imported into Pangkor or transported from the principal customs area to Pangkor at the rate of import duty specified in column (5) of the First Schedule to the Customs Duties Order 2025 [P.U. (A) 384/2025].

Revocation

3. The Customs Duties (Pangkor) Order 2019 [P.U. (A) 413/2019] is revoked.
