CUSTOMS ACT 1967

CUSTOMS DUTIES (GOODS OF ASEAN COUNTRIES ORIGIN) (ASEAN HARMONISED TARIFF NOMENCLATURE AND COMMON EFFECTIVE PREFERENTIAL TARIFF) (AMENDMENT) (NO.3) ORDER 2009

IN exercise of the powers conferred by subsection 11(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Goods of ASEAN Countries Origin) (ASEAN Harmonised Tariff Nomenclature and Common Effective Preferential Tariff) (Amendment) (No. 3) Order 2009**.

(2) This Order comes into operation on 1 August 2009.
