SALES TAX ACT 1972

SALES TAX (EXEMPTION) (AMENDMENT) (NO. 4) ORDER 2012

IN exercise of the powers conferred by section 8 of the Sales Tax Act 1972 [*Act 64*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Sales Tax (Exemption) (Amendment) (No. 4) Order 2012**.

(2) This Order is deemed to come into operation on 1 January 2012.

Amendment of Schedule A

2. The Sales Tax (Exemption) Order 2008 [*P.U. (A) 91/2008*] is amended in Schedule A, in relation to heading 84.70 by inserting after subheading 8470.30 and the particulars relating to the subheading the following particulars:
