

## AKTA KASTAM 1967

### PERINTAH DUTI KASTAM (PENGECUALIAN) (PINDAAN) ( NO. 5 ) 2010

PADA menjalankan kuasa yang diberikan oleh subseksyen 14(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

#### Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Duti Kastam (Pengecualian) (Pindaan) (No. 5 ) 2010.**

(2) Perintah ini mula berkuat kuasa pada 1 September 2010.

#### Pindaan Jadual

2. Perintah Duti Kastam (Pengecualian) 1988 [*P.U. (A) 410/1987*] dipinda dalam Bahagian I Jadual dengan menggantikan butiran 94 dan butir-butir yang berhubungan dengannya butiran yang berikut:

(1) <i>No.</i>	(2) <i>Persons Exempted</i>	(3) <i>Goods Exempted</i>	(4) <i>Conditions</i>	(5) <i>Certificate to be signed by</i>
“94.	The Importer	Empty containers including bottles, drums, cylinders and other reusable packaging material exported and subsequently reimported	(i) That a notice is given at the time of export that the reusable packaging material will be reimported;  (ii) that the proper officer of customs is satisfied that they are being returned to Malaysia after having been exported containing the goods	The Importer”.

## CUSTOMS ACT 1967

### CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) ( NO . 5 ) ORDER 2010

In exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

#### Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment)(No. 5 ) Order 2010**.

(2) This Order comes into operation on 1 September 2010.

#### Amendment of Schedule

2. The Customs Duties (Exemption) Order 1988 [P.U. (A) 410/1987] is amended in Part I of the Schedule by substituting for item 94 and the particulars relating to it the following item:

(1) <i>No.</i>	(2) <i>Persons Exempted</i>	(3) <i>Goods Exempted</i>	(4) <i>Conditions</i>	(5) <i>Certificate to be signed by</i>
“94.	The Importer	Empty containers including bottles, drums, cylinders and other reusable packaging material exported and subsequently reimported	(i) That a notice is given at the time of export that the reusable packaging material will be reimported;  (ii) that the proper officer of customs is satisfied that they are being returned to Malaysia after having been exported containing the goods	The Importer”.
