CUSTOMS ACT 1967

CUSTOMS (PROHIBITION OF EXPORTS) (AMENDMENT) ORDER 2023

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs (Prohibition of Exports) (Amendment) Order 2023**.

(2) This Order comes into operation on 1 October 2023.

Amendment of Second Schedule
