

## AKTA KASTAM 1967

### PERINTAH KASTAM (LARANGAN MENGENAI IMPORT) (PINDAAN) (NO. 2) 2009

PADA menjalankan kuasa yang diberikan oleh subseksyen 31(1) Akta Kastam 1967 [Akta 235], Menteri membuat perintah yang berikut:

#### Nama dan permulaan kuat kuasa

1. (1) Perintah ini bolehlah dinamakan **Perintah Kastam (Larangan Mengenai Import) (Pindaan) (No. 2) 2009**.

(2) Perintah ini mula berkuat kuasa pada 1 Ogos 2009.

#### Pindaan Jadual Keempat

2. Perintah Kastam (Larangan Mengenai Import) 2008 [P.U.(A) 86/2008] dipinda dalam Jadual Keempat, Bahagian III, dengan menggantikan butiran 1 dan butir-butir yang berhubungan dengannya dengan butiran yang berikut:

## CUSTOMS ACT 1967

### CUSTOMS (PROHIBITION OF IMPORTS) (AMENDMENT) (NO.2) ORDER 2009

IN exercise of the powers conferred by subsection 31(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

#### Citation and Commencement

1. (1) This order may be cited as the **Customs (Prohibition of Imports) (Amendment) (No. 2) Order 2009**.
- (2) This Order comes into operation on 1 August 2009.

#### Amendment of Fourth Schedule

2. The Customs (Prohibition of Imports) Order 2008 [*P.U.(A) 86/2008*] is amended in the Fourth Schedule, in Part III, by substituting for item 1 and the particulars relating to it the following item:
