AKTA KASTAM 1967

PERATURAN-PERATURAN KASTAM (PINDAAN) (NO. 4) 2023

PADA menjalankan kuasa yang diberikan oleh seksyen 142 Akta Kastam 1967 [*Akta 235*], Menteri membuat peraturan-peraturan yang berikut:

Nama dan permulaan kuat kuasa

1. (1) Peraturan-peraturan ini bolehlah dinamakan **Peraturan-Peraturan Kastam (Pindaan) (No. 4) 2023**.

(2) Peraturan-Peraturan ini mula berkuat kuasa pada 1 Januari 2024.

Pindaan peraturan 6

2. Peraturan-Peraturan Kastam 2019 [*P.U. (A) 397/2019*] dipinda dalam subperaturan 6(3)—

(a) dengan memasukkan selepas perkataan “rokok” perkataan “atau minuman keras yang memabukkan”; dan

(b) dengan menggantikan perenggan (c) dengan perenggan yang berikut:

“(c) di tebing kiri Sungai Pulai di—

(i) Dermaga 1 hingga Dermaga 6 yang terletak di garis lintang $1^{\circ} 22' 27.885''$ U garis bujur $103^{\circ} 32' 37.0024''$ T hingga garis lintang $1^{\circ} 21' 20.4208''$ U garis bujur $103^{\circ} 32' 56.7317''$ T;

(ii) Dermaga 7 hingga Dermaga 14 yang terletak di garis lintang $1^{\circ} 21' 18.16972''$ U garis bujur $103^{\circ} 32' 51.34746''$ T hingga garis lintang $1^{\circ} 19' 48.91932''$ U garis bujur $103^{\circ} 33' 26.76954''$ T”.

CUSTOMS ACT 1967

CUSTOMS (AMENDMENT) (NO. 4) REGULATIONS 2023

IN exercise of the powers conferred by section 142 of the Customs Act 1967 [Act 235], the Minister makes the following regulations:

Citation and commencement

1. (1) These regulations may be cited as the **Customs (Amendment) (No. 4) Regulations 2023**.

(2) These Regulations come into operation on 1 January 2024.

Amendment of regulation 6

2. The Customs Regulations 2019 [P.U. (A) 397/2019] are amended in subregulation 6(3)—

(a) by inserting after the word “cigarettes” the words “or intoxicating liquor”;
and

(b) by substituting for paragraph (c) the following paragraph:

“(c) on the left bank of Sungai Pulai at—

(i) Wharf 1 to Wharf 6 located at latitude 1° 22' 27.885" N
longitude 103° 32' 37.0024" E to latitude 1° 21' 20.4208" N
longitude 103° 32' 56.7317" E;

(ii) Wharf 7 to Wharf 14 located at latitude 1° 21' 18.16972" N
longitude 103° 32' 51.34746" E to latitude 1° 19' 48.91932" N
longitude 103° 33' 26.76954" E ”.
