AKTA KASTAM 1967

PERINTAH DUTI KASTAM (PENGEQUALIAN) (PINDAAN) 2023

CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) ORDER 2023

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [Act 235], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) Order 2023**.

(2) This Order comes into operation on 9 March 2023.

Amendment of Schedule

2. The Customs Duties (Exemption) Order 2017 [P.U. (A) 445/2017] is amended in the Schedule, in Part I by substituting for item 94 and the particulars relating to it the following item and particulars:
