CUSTOMS ACT 1967

CUSTOMS DUTIES (EXEMPTION) (AMENDMENT) ORDER 2009

IN exercise of the powers conferred by subsection 14(1) of the Customs Act 1967 [*Act 235*], the Minister makes the following order:

Citation and commencement

1. (1) This order may be cited as the **Customs Duties (Exemption) (Amendment) Order 2009**.

(2) This Order comes into operation on 1 August 2009 .
